General Information About Childhood Central Nervous System (CNS) Atypical Teratoid/Rhabdoid Tumor




- Central nervous system atypical teratoid/rhabdoid tumor is a disease in which malignant (cancer) cells form in the tissues of the brain.
- Certain genetic changes may increase the risk of atypical teratoid/rhabdoid tumor.

- Tests that examine the brain and spinal cord are used to detect (find) CNS atypical teratoid/rhabdoid tumor.

Central nervous system atypical teratoid/rhabdoid tumor is a disease in which malignant (cancer) cells form in the tissues of the brain.

Central nervous system (CNS) atypical teratoid/rhabdoid tumor (AT/RT) is a very rare, fast-growing tumor of the brain and spinal cord. It usually occurs in children aged three years and younger, although it can occur in older children and adults.

About half of these tumors form in the <u>cerebellum</u> or <u>brain stem</u>. The cerebellum is the part of the brain that controls movement, balance, and posture. The brain stem controls breathing, heart rate, and the nerves and muscles used in seeing, hearing, walking, talking, and eating. AT/RT may also be found in other parts of the central nervous system (brain and spinal cord).

This summary describes the treatment of <u>primary brain tumors</u> (tumors that begin in the brain). Treatment for metastatic brain tumors, which are tumors formed by <u>cancer cells</u> that begin in other parts of the body and spread to the brain, is not covered in this summary. For more information, see the PDQ summary on Childhood Brain and Spinal Cord Tumors Treatment Overview about the different types of childhood brain and spinal cord tumors.

Brain tumors can occur in both children and adults; however, treatment for children may be different than treatment for adults. See the PDQ treatment summary on Adult Central Nervous System Tumors Treatment for more information.

Certain genetic changes may increase the risk of atypical teratoid/rhabdoid tumor.

Anything that increases the risk of getting a disease is called a <u>risk factor</u>. Having a risk factor does not mean that you will get cancer; not having risk factors doesn't mean that you will not get cancer. Talk with your child's doctor if you think your child may be at risk.

Atypical teratoid/rhabdoid tumor may be linked to changes in the tumor suppressor genes *SMARCB1* or *SMARCA4*. Genes of this type make a protein that helps control cell growth. Changes in the <u>DNA</u> of tumor suppressor genes like *SMARCB1* or *SMARCA4* may lead to cancer.

Changes in the *SMARCB1* or *SMARCA4* genes may be inherited (passed on from parents to offspring). When this gene change is inherited, tumors may form in two parts of the body at the same time (for example, in the brain and the kidney). For patients with AT/RT, genetic counseling (a discussion with a trained professional about inherited diseases and a possible need for gene testing) may be recommended.

The signs and symptoms of atypical teratoid/rhabdoid tumor are not the same in every patient.

Signs and symptoms depend on the following:

• The child's age.

• Where the tumor has formed.

Because atypical teratoid/rhabdoid tumor is fast growing, signs and symptoms may develop quickly and get worse over a period of days or weeks. Signs and symptoms may be caused by AT/RT or by other conditions. Check with your child's doctor if your child has any of the following:

- Morning headache or headache that goes away after vomiting.
- Nausea and vomiting.
- Unusual sleepiness or change in activity level.
- Loss of balance, lack of coordination, or trouble walking.
- Increase in head size (in infants).


Tests that examine the brain and spinal cord are used to detect (find) CNS atypical teratoid/rhabdoid tumor.

The following tests and procedures may be used:

- <u>Physical exam</u> and health history: An exam of the body to check general signs of health, including checking for signs of disease, such as lumps or anything else that seems unusual. A history of the patient's health habits and past illnesses and treatments will also be taken.
- Neurological exam: A series of questions and tests to check the brain, spinal cord, and nerve function. The exam checks a person's mental status, coordination, and ability to walk normally, and how well the muscles, senses, and reflexes work. This may also be called a neuro exam or a neurologic exam.
- MRI (magnetic resonance imaging): A procedure that uses a magnet, <u>radio waves</u>, and a computer to make a series of detailed pictures of areas inside the brain and spinal cord. This procedure is also called nuclear magnetic resonance imaging (NMRI).
- <u>Lumbar puncture</u>: A procedure used to collect <u>cerebrospinal fluid</u> (CSF) from the <u>spinal column</u>. This is done by placing a needle between two bones in the <u>spine</u> and into the CSF around the spinal cord and removing a sample of fluid. The sample of CSF is checked under a <u>microscope</u> for signs of tumor cells. The sample may also be checked for the amounts of <u>protein</u> and <u>glucose</u>. A higher than normal amount of protein or lower than normal amount of glucose may be a sign of a tumor. This procedure is also called an LP or spinal tap.
- *SMARCB1* and *SMARCA4* gene testing: A <u>laboratory test</u> in which a sample of <u>blood</u> or <u>tissue</u> is tested for certain changes in the *SMARCB1* and *SMARCA4* genes.

Childhood atypical teratoid/rhabdoid tumor is diagnosed and may be removed in surgery.

If doctors think there might be a brain tumor, a biopsy may be done to remove a sample of tissue. For tumors in the brain, the biopsy is done by removing part of the skull and using a needle to remove a sample of tissue. A pathologist views the tissue under a microscope to look for cancer cells. If cancer cells are found, the doctor may remove as much tumor as safely possible during the same surgery. The pathologist checks the cancer cells to find out the type of brain tumor. It is often difficult to completely remove AT/RT because of where the tumor is in the brain and because it may already have spread at the time of diagnosis.



The following test may be done on the sample of tissue that is removed:

• Immunohistochemistry: A laboratory test that uses antibodies to check for certain antigens (markers) in a sample of a patient's tissue. The antibodies are usually linked to an enzyme or a fluorescent dye. After the antibodies bind to a specific antigen in the tissue sample, the enzyme or dye is activated, and the antigen can then be seen under a microscope. This type of test is used to help diagnose cancer and to help tell one type of cancer from another type of cancer.

Certain factors affect prognosis (chance of recovery) and treatment options.

The prognosis and treatment options depend on the following:

- Whether there are certain inherited gene changes.
- The age of the child.

- The amount of tumor remaining after surgery.
- Whether the cancer has spread to other parts of the central nervous system (brain and spinal cord) or to the kidney at the time of diagnosis.

Stages of Childhood CNS Atypical Teratoid/Rhabdoid Tumor

The process used to find out if <u>cancer</u> has spread to other parts of the body is called <u>staging</u>. There is no standard staging system for central nervous system atypical teratoid/rhabdoid tumor.

For treatment, this tumor is grouped as newly diagnosed or recurrent. Treatment depends on the following:

- The age of the child.
- How much cancer remains after surgery to remove the tumor.

Results from the following procedure are also used to plan treatment:

Ultrasound exam: A procedure in which high-energy sound waves (ultrasound) are bounced off internal tissues
or organs, such as the kidney, and make echoes. The echoes form a picture of body tissues called a sonogram.
The picture can be printed to be looked at later. This procedure is done to check for tumors that may also have
formed in the kidney.

Treatment Option Overview

There are different types of treatment for patients with central nervous system atypical teratoid/rhabdoid tumor.

Different types of treatment are available for patients with <u>central nervous system atypical teratoid/rhabdoid tumor</u> (AT/RT). Treatment for AT/RT is usually within a <u>clinical trial</u>. A treatment clinical trial is a <u>research study</u> meant to help improve current treatments or obtain information on new treatments for patients with cancer.

Clinical trials are taking place in many parts of the country. Information about ongoing clinical trials is available from the NCI website. Choosing the most appropriate cancer treatment is a decision that ideally involves the patient, family, and health care team.

Children with atypical teratoid/rhabdoid tumor should have their treatment planned by a team of health care providers who are experts in treating cancer in children.

Treatment will be overseen by a <u>pediatric oncologist</u>, a doctor who specializes in treating children with cancer. The pediatric oncologist works with other <u>pediatric health care providers</u> who are experts in treating children with central nervous system cancer and who specialize in certain areas of medicine. These may include the following specialists:

- Pediatrician.
- Pediatric neurosurgeon.
- Radiation oncologist.
- Neurologist.
- Pediatric nurse specialist.
- Rehabilitation specialist.
- Psychologist.
- · Social worker.
- Geneticist or genetic counselor.

Childhood brain tumors may cause signs or symptoms that begin before the cancer is diagnosed and continue for months or years.

<u>Signs</u> or <u>symptoms</u> caused by the <u>tumor</u> may begin before <u>diagnosis</u>. These signs or symptoms may continue for months or years. It is important to talk with your child's doctors about signs or symptoms caused by the tumor that may continue after treatment.

Four types of treatment are used:

Surgery

Surgery is used to diagnose and treat CNS atypical teratoid/rhabdoid tumor. See the General Information section of this summary for more information about how this tumor is diagnosed.

After the doctor removes all the cancer that can be seen at the time of the surgery, most patients will be given chemotherapy and possibly <u>radiation therapy</u> after surgery to kill any cancer <u>cells</u> that are left. Treatment given after the surgery, to lower the risk that the cancer will come back, is called adjuvant therapy.

Chemotherapy

Chemotherapy is a cancer treatment that uses <u>drugs</u> to stop the growth of cancer cells, either by killing the cells or by stopping them from dividing.

- Chemotherapy drugs injected into the cerebrospinal fluid are able to reach the tumor. This is called intrathecal chemotherapy.
- When chemotherapy is taken by mouth or injected into a <u>vein</u> or muscle, the drugs enter the bloodstream and can reach tumor cells throughout the body (systemic chemotherapy). Although most cannot, some oral <u>chemotherapy</u> drugs can cross the blood-brain barrier and reach the tumor. High <u>doses</u> of some chemotherapy drugs given into a vein can cross the blood-brain barrier and reach the tumor.

Radiation therapy

Radiation therapy is a cancer treatment that uses high-energy <u>x-rays</u> or other types of <u>radiation</u> to kill cancer cells or keep them from growing. <u>External radiation therapy</u> uses a machine outside the body to send radiation toward the area of the body with cancer.

External radiation therapy may be given to the brain and spinal cord.

Because radiation therapy can affect growth and brain development in young children, especially children who are three years old or younger, the dose of radiation therapy may be lower than in older children.

High-dose chemotherapy with stem cell transplant

High doses of chemotherapy are given to kill cancer cells. Healthy cells, including <u>blood</u>-forming cells, are also destroyed by the cancer treatment. <u>Stem cell transplant</u> is a treatment to replace the blood-forming cells. <u>Stem cells</u> (immature blood cells) are removed from the blood or <u>bone marrow</u> of the patient or a <u>donor</u> and are frozen and stored. After the patient completes chemotherapy, the stored stem cells are thawed and given back to the patient through an infusion. These reinfused stem cells grow into (and restore) the body's blood cells.

New types of treatment are being tested in clinical trials.

This summary section describes treatments that are being studied in <u>clinical trials</u>. It may not mention every new treatment being studied. Information about clinical trials is available from the NCI website.

Targeted therapy

<u>Targeted therapy</u> is a type of treatment that uses drugs or other substances to identify and attack specific cancer cells. Targeted therapies usually cause less harm to normal cells than chemotherapy or radiation therapy do. Targeted therapy is being studied in the treatment of recurrent childhood central nervous system atypical teratoid/rhabdoid tumor.

Treatment for childhood central nervous system atypical teratoid/rhabdoid tumors may cause side effects.

For information about side effects that begin during treatment for cancer, see our Side Effects page.

Side effects from cancer treatment that begin after treatment and continue for months or years are called <u>late effects</u>. Late effects of cancer treatment may include the following:

- Physical problems.
- Changes in mood, feelings, thinking, learning, or memory.
- Second cancers (new types of cancer).

Some late effects may be treated or controlled. It is important to talk with your child's doctors about the effects cancer treatment can have on your child. (See the PDQ summary on Late Effects of Treatment for Childhood Cancer for more information).

Patients may want to think about taking part in a clinical trial.

For some patients, taking part in a <u>clinical trial</u> may be the best treatment choice. Clinical trials are part of the cancer research process. Clinical trials are done to find out if new cancer treatments are safe and effective or better than the standard treatment.

Many of today's standard treatments for cancer are based on earlier clinical trials. Patients who take part in a clinical trial may receive the standard treatment or be among the first to receive a new treatment.

Patients who take part in clinical trials also help improve the way cancer will be treated in the future. Even when clinical trials do not lead to effective new treatments, they often answer important questions and help move research forward.

Patients can enter clinical trials before, during, or after starting their cancer treatment.

Some clinical trials only include patients who have not yet received treatment. Other trials test treatments for patients whose cancer has not gotten better. There are also clinical trials that test new ways to stop cancer from recurring (coming back) or reduce the side effects of cancer treatment.

Clinical trials are taking place in many parts of the country. Information about clinical trials supported by NCI can be found on NCI's <u>clinical trials search</u> webpage. Clinical trials supported by other organizations can be found on the ClinicalTrials.gov website.

Follow-up tests may be needed.

Some of the tests that were done to diagnose the cancer may be repeated. Some tests will be repeated in order to see how well the treatment is working. Decisions about whether to continue, change, or stop treatment may be based on the results of these tests.

Some of the tests will continue to be done from time to time after treatment has ended. The results of these tests can show if your child's <u>condition</u> has changed or if the cancer has <u>recurred</u> (come back). These tests are sometimes called follow-up tests or check-ups.

Combinations of treatments are used for patients with atypical teratoid/rhabdoid tumor.

Because newly diagnosed atypical teratoid/rhabdoid tumor (AT/RT) is fast-growing, a combination of treatments is usually given. After surgery to remove the tumor, treatments for AT/RT may include combinations of the following:

- Chemotherapy.
- Radiation therapy.
- High-dose chemotherapy with stem cell transplant.

<u>Clinical trials</u> of new treatments should be considered for patients with newly diagnosed atypical teratoid/rhabdoid tumor.

Treatment of Recurrent Childhood CNS Atypical Teratoid/Rhabdoid Tumor

There is no standard treatment for patients with recurrent childhood central nervous system atypical teratoid/rhabdoid tumor. Treatment may include the following:

- Palliative treatment to improve quality of life.
- A clinical trial of targeted therapy.
- A clinical trial that checks a sample of the patient's <u>tumor</u> for certain <u>gene</u> changes. The type of targeted therapy that will be given to the patient depends on the type of gene change.

Clinical Trial Information

A clinical trial is a study to answer a scientific question, such as whether one treatment is better than another. Trials are based on past studies and what has been learned in the laboratory. Each trial answers certain scientific questions in order to find new and better ways to help cancer patients. During treatment clinical trials, information is collected about the effects of a new treatment and how well it works. If a clinical trial shows that a new treatment is better than one currently being used, the new treatment may become "standard." Patients may want to think about taking part in a clinical trial. Some clinical trials are open only to patients who have not started treatment.
